In accordance to Section 1337.05 of the Middleburg Heights Codified Ordinance:

Application for **filling/grade change** is to be submitted to the Division of Building who then will refer such application to the City Engineer. No permit shall be issued unless it is found the proposed change in grade, with such provisions for drainage and such drainage facilities as the applicant proposes in connection therewith, will not:

- 1) Create a nuisance upon such property by obstruction of the natural drainage of water from such property;
- 2) Adversely affect adjacent property by diversion of surface water or by the increase in the rate of run-off of surface water onto such adjacent property or by interference with, or obstruction of natural drainage of water from such adjacent property;
- 3) Interfere with or obstruct the public water, sanitary or storm systems or a natural watercourse; and
- 4) Create a nuisance by permitting the type of fill material used to flow or be washed or drained onto adjacent property, or into a natural watercourse, or into the public water, sanitary or sewer systems.

- ITEMS REQUIRED WHEN SUBMITTING APPLICATION FOR FILLING/GRADE CHANGE:

- 1) Permit application; properly completed; contractor listed must be registered
- 2) \$300 deposit for site plan review and site inspections. Any remaining monies will be refunded to the depositor in the form of a check, issued by the Finance Department. Additional fees incurred must be collected prior to issuance of permit.
- 3) 3 Drawings stamped by an Ohio Registered Surveyor or Registered Engineer showing:
 - existing and proposed grades
 - proposed drainage
 - proposed sediment control

- PERMIT FEES:

\$30 plus a \$500 bond, which, upon completion and final inspection of site work, any remaining monies will be refunded to the depositor in the form of a check, issued by the Finance Department.
