### A RESOLUTION

#### AUTHORIZING THE SALE OF CERTAIN CITY OWNED VEHICLES AND EQUIPMENT NO LONGER NEEDED FOR ANY MUNICIPAL PURPOSE

WHEREAS, the City has title to a 2012 Dodge Charger VIN 2C3CDXAT2CH260987, a 2012 Dodge Charger VIN 2C3CDXAT9CH260985 and a 2003 International 7400 VIN 1HTWDAAR43J061371 which are no longer needed for any municipal purpose.

WHEREAS, the City owns a 2003 New Holland Backhoe S/N 031033412, a 2007 Bobcat ToolCat 5600 S/N AOW111268, a 2000 Ford Tractor S/N C374772, a Mavron Animal Control Truck Body S/N 0212135, a 1999 Diamond Products Corecut Saw with trailer S/N 12512222, a Henderson Muni-Body S/N 10XX36XRDOX30455, and a 1997 Upright X31N Scissorlift S/N 67666 which are no longer needed for any municipal purpose.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF MIDDLEBURG HEIGHTS, STATE OF OHIO, AS FOLLOWS:

Section 1: That the Service Director is hereby authorized to sell the above listed vehicles and equipment through the Greater Cleveland Auto Auction or GovDeals.

Section 2.
