**A RESOLUTION  
AUTHORIZING THE MAYOR AND FINANCE DIRECTOR TO ENTER INTO  
AN AGREEMENT WITH BROWNING FERRIS INDUSTRIES OF OHIO, INC.  
(dba Republic Services) FOR RESIDENTIAL WASTE COLLECTION,  
DISPOSAL AND RECYCLING SERVICES**

WHEREAS, due to the COVID-19 "Stay at Home" order issued by Ohio Governor Mike DeWine, the bid opening scheduled on Monday, April 13, 2020 for Solid Waste Collection was rescheduled for Monday, April 27, 2020; and

WHEREAS, pursuant to legal advertisement duly made, sealed bids were received on April 27, 2020 for RESIDENTIAL SOLID WASTE COLLECTION, DISPOSAL AND RECYCLING SERVICES in accordance with specifications on file in the Council Office; and

WHEREAS, the bid of Browning Ferris Industries of Ohio, Inc. dba Republic Services of Elyria, 40195 Butternut Ridge Road, Elyria, OH 44035 for Residential Waste Collection, Disposal and Recycling Services is determined to be the lowest and best bid; therefore.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF MIDDLEBURG HEIGHTS, STATE OF OHIO, AS FOLLOWS:

Section 1: That the bid of Browning Ferris Industries of Ohio, Inc. dba Republic Services of Elyria, 40195 Butternut Ridge Road, Elyria, OH 44035 for Residential Solid Waste Collection, Disposal and Recycling Services beginning September 7, 2020 and will terminate on September 7, 2025, unless renewed with the option for five additional one-year terms upon the same terms and conditions specified in the bid being the lowest and best bid submitted pursuant to legal advertisement and specifications on file with the Clerk of Council, be and the same is hereby accepted.

Section 2: That the Mayor and Finance Director are authorized to enter into a contract with Browning Ferris Industries of Ohio, Inc. dba Republic Services of Elyria in accordance with Section 1 of this Resolution.

Section 3: That there is hereby appropriated from the General Fund sufficient funds to implement this Resolution.

Section 4: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements, including Chapter 107 of the Middleburg Heights Code and Section 121.22 of the Ohio Revised Code.
