**A RESOLUTION
WAIVING PERMIT FEES FOR SOUTHWEST GENERAL HEALTH CENTER
FOR THE RENOVATION AND EXPANSION OF THE MATERNITY
SERVICES FACILITY**

WHEREAS, Southwest General Health Center has a deep commitment to providing personalized care and building a healthy future for the patients, families and communities it serves; and

WHEREAS, Southwest General Health Center is dedicated to providing outstanding, family-centered care to provide an optimal birth experience, offering numerous maternity services designed to help both before and after birth, including childbirth and family life classes; and

WHEREAS, the Maternity Services facility will undergo a 17,000 square foot interior expansion and renovation of the existing space; and

WHEREAS, contractor registrations and plan review fees will not be waived.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF MIDDLEBURG HEIGHTS, STATE OF OHIO, AS FOLLOWS:

Section 1: That Council hereby authorizes 25% of the estimated \$90,531.95 permit fees for the expansion and renovations of the existing space for the Maternity Services at Southwest General Health Center be waived.

Section 2: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements, including Chapter 107 of the Middleburg Heights Code and Section 121.22 of the Ohio Revised Code.
