**A RESOLUTION  
WAIVING PERMIT FEES FOR SOUTHWEST GENERAL HEALTH CENTER  
FOR RENOVATION OF THE MRI VASCULAR LAB**

WHEREAS, Southwest General Health Center has a deep commitment to providing personalized care and building a healthy future for the patients, families and communities it serves; and

WHEREAS, Magnetic Resonance Imaging is a painless diagnostic exam that allows physicians to see inside the body without using surgery or radiation. MRI uses a magnetic field, radio waves and a computer to create detailed images of the internal organs and tissues; and

WHEREAS, Southwest General Health Center will undergo renovation of the MRI Vascular Lab; and

WHEREAS, contractor registrations and plan review fees will not be waived.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF MIDDLEBURG HEIGHTS, STATE OF OHIO, AS FOLLOWS:

Section 1: That Council hereby authorizes 25% of the estimated \$8,978.92 permit fees for the renovations of the existing space for the MRI Vascular Lab at Southwest General Health Center be waived.

Section 2: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements, including Chapter 107 of the Middleburg Heights Code and Section 121.22 of the Ohio Revised Code.
