**A RESOLUTION  
AUTHORIZING THE FIRE CHIEF TO DONATE  
FIREFIGHTING PERSONAL PROTECTIVE EQUIPMENT  
NO LONGER NEEDED FOR ANY MUNICIPAL PURPOSE**

WHEREAS, the Middleburg Heights Fire Department is in possession of old and obsolete firefighting personal protective equipment which has little, if any, monetary value, is well over 10 years old and no longer suitable for use based on NFPA standards, and is no longer needed for any municipal purpose; and

WHEREAS, the Rotary Club of Strongsville has the opportunity to make donations to underprivileged foreign countries that would benefit from firefighting personal protective equipment, such as jackets and pants; and

WHEREAS, it would be in the best interest of the City of Middleburg Heights to donate the firefighting personal protective equipment to the Rotary Club of Strongsville.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF MIDDLEBURG HEIGHTS, STATE OF OHIO, AS FOLLOWS:

Section 1: That this Council finds that the Fire Department of the City of Middleburg Heights has firefighting personal protective equipment, jackets and pants, which are well over 10 years old and no longer suitable for use based on NFPA standards, and are no longer needed for any municipal purpose; and further finds that it would be in the best interest of the City to dispose of such equipment by donation and transfer to the Rotary Club of Strongsville in lieu of auction or salvage.

Section 2: That the Fire Chief and Director of Finance are hereby authorized to implement for donation the transfer of the equipment to the Rotary Club of Strongsville.

Section 3: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements, including Chapter 107 of the Middleburg Heights Code and Section 121.22 of the Ohio Revised Code.
