**A RESOLUTION  
ACCEPTING THE BID OF FABRIZI TRUCKING AND PAVING CO., INC.  
FOR THE 2021 STREET REPAIR PROGRAM PHASE 1  
MIDDLEBROOK BOULEVARD REHABILITATION**

WHEREAS, pursuant to legal advertisement duly made, sealed bids were received on March 22, 2021 for the 2021 Street Repair Program Phase 1 Middlebrook Boulevard Rehabilitation, in accordance with specifications prepared by the City Engineer. The work generally includes asphalt pavement planing and resurfacing, single pass in place recycling and storm sewer installation; and

WHEREAS, the bid of Fabrizi Trucking and Paving Co., Inc., 20389 First Avenue, Middleburg Heights, OH 44130 for the 2021 Street Repair Program Phase 1 Middlebrook Boulevard Rehabilitation in the amount of \$555,515.48 is determined to be the lowest and best bit, therefore.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF MIDDLEBURG HEIGHTS, STATE OF OHIO, AS FOLLOWS:

Section 1: That the bid of Fabrizi Trucking and Paving Co., Inc. for the 2021 Street Repair Program Phase 1 Middlebrook Boulevard Rehabilitation in the amount of \$555,515.48 being the lowest and best bid submitted pursuant to legal advertisement and specifications prepared by the City Engineer, be and the same is hereby accepted.

Section 2: That the Mayor and Finance Director are hereby authorized to enter into a contract with Fabrizi Trucking and Paving Co., Inc., 20389 First Avenue, Middleburg Heights, OH 44130 in accordance with Section 1 of this Resolution.

Section 3: That there is hereby appropriated sufficient money from the Street Infrastructure Improvement Fund to implement this Resolution.

Section 4: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal actions were in meetings open to the public,

in compliance with all legal requirements, including Chapter 107 of the Middleburg Heights Code and Section 121.22 of the Ohio Revised Code.
