**AN ORDINANCE
AUTHORIZING THE MAYOR TO ENTER INTO A CONTRACT EXTENSION
WITH SENIOR TRANSPORTATION CONNECTION OF CUYAHOGA
COUNTY FOR SENIOR TRANSPORTATION SERVICES
AND DECLARING AN EMERGENCY**

WHEREAS, the City desires to retain the services of a competent and qualified contractor to provide certain senior transportation services to the City; and

WHEREAS, Senior Transportation Connection is competent and qualified to furnish services to the City and has provided a responsive and responsible proposal, and desires to continue to provide transportation services.

**BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MIDDLEBURG
HEIGHTS, CUYAHOGA COUNTY, STATE OF OHIO:**

Section 1. That the Mayor is hereby authorized to enter into a contract extension with Senior Transportation Connection of Cuyahoga County to provide certain senior transportation services to the City, a copy of which is attached hereto and marked "Exhibit A".

Section 2. That it is hereby found and determined that all formal actions of this council concerning and relating to the passage of this ordinance were adopted in an open meeting of this council, and that all deliberations of this council and any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements including chapter 107 of the Codified Ordinances and section 121.22 of Ohio Revised Code.

Section 3. That this ordinance is hereby declared to be an emergency measure, immediately necessary for the preservation of the public peace, health and safety of the citizens of the City of Middleburg Heights, Ohio. Therefore, this ordinance shall take effect and be in force immediately upon its passage and approval by the Mayor.

**First Amendment to Transportation Services Contract
City of Middleburg Heights and Senior Transportation Connection**

This amendment (the "Amendment") is made by the City of Middleburg Heights ("City") and Senior Transportation Connection ("STC"), parties to the agreement Transportation Services Contract dated March 19, 2018 (the "Contract".)

The contract is amended as follows

1. **Term:** This amendment is effective March 31, 2020 through December 31, 2022 unless either party serves written notice to the other party at least ninety (90) days prior to the end of the term.
2. **Fees:** As compensation for the services provided by Contractor hereunder, the City shall pay Contractor a fixed fee of \$7,300.00 per month.
3. Except as set forth in this Amendment, the Contract is unaffected and shall continue in full force and effect in accordance with its terms. If there is a conflict between this amendment and the Contract or any earlier amendment, the terms of this amendment will prevail.
