**AN ORDINANCE
ACCEPTING THE PLAT OF LOT CONSOLIDATION AND DEDICATION
FOR A CERTAIN PORTION OF PEARL ROAD AS SHOWN ON THE
DAXABEN & BIREN PATEL PLAT**

WHEREAS, Daxaben & Biren Patel have submitted a plat of lot consolidation and right of way dedication on which a certain portion of Pearl Road is offered for dedication; and

WHEREAS, the City Engineer has reviewed the plat of consolidation and dedication and the Planning Commission has approved it; and

WHEREAS, the Council of the City of Middleburg Heights wishes to accept said dedication.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MIDDLEBURG HEIGHTS, STATE OF OHIO, AS FOLLOWS:

Section 1: That the Council of the City of Middleburg Heights hereby accepts the dedication of a portion of Pearl Road as shown on the Daxaben & Biren Patel consolidation plat, a copy of which is attached hereto and marked "Exhibit A".

Section 2: That the Clerk of Council is hereby authorized to sign the attached consolidation plat.


