**A RESOLUTION
AUTHORIZING THE MAYOR AND FINANCE DIRECTOR TO ENTER INTO
A CONTRACT WITH PETROLEUM TRADERS CORPORATION, INC.
FOR THE FURNISHING OF UNLEADED GASOLINE**

WHEREAS, pursuant to legal advertisement duly made, sealed bids were received on May 10, 2021, for the furnishing of UNLEADED GASOLINE in accordance with specifications on file with the Clerk of Courts; and

WHEREAS, the bid of Petroleum Traders Corporation, Inc., P.O. Box 2357, Fort Wayne, IN 46801-2357 for the furnishing of 80,000 gallons of unleaded gasoline with an octane rating of 87 ethanol for the price of \$2.0778 per gallon as required by the City of Middleburg Heights for a period of two (2) years was determined to be the lowest and best bid.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF MIDDLEBURG HEIGHTS, STATE OF OHIO, AS FOLLOWS:

Section 1: That the bid of Petroleum Traders Corporation, Inc., P.O. Box 2357, Fort Wayne, IN 46801-2357 for the furnishing of 80,000 gallons of unleaded gasoline with an octane rating of 87 ethanol for the price of \$2.0778 per gallon as required by the City of Middleburg Heights for a period of two (2) years pursuant to its written bid is hereby accepted.

Section 2: That the Mayor and Finance Director are hereby authorized to enter into a contract with Petroleum Traders Corporation, Inc. in accordance with bid specifications.

Section 3: That there is hereby appropriated sufficient funds to implement this Resolution.

Section 4: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements, including Chapter 107 of the Middleburg Heights Code and Section 121.22 of the Ohio Revised Code.
