**A RESOLUTION
ACCEPTING THE BID OF CHIEFTAIN TRUCKING & EXCAVATION
FOR THE CITY HALL PARK DETENTION BASIN
IMPROVEMENT PROJECT**

WHEREAS, pursuant to legal advertisement duly made, sealed bids were received on July 19, 2021, for the 2021 City Hall Park Detention Basin Improvement Project, in accordance with specifications prepared by the City Engineer; and

WHEREAS, the work generally includes clearing, grubbing, excavation, embankment, seeding and mulching, a proposed storm water detention basin and constructing an outlet structure; and

WHEREAS, the bid of Chieftain Trucking & Excavation, 3926 Valley Road, Cleveland, OH 44109 for the 2021 City Hall Park Detention Basin Improvement Project in the amount of \$107,964.00 is determined to be the lowest and best bid, therefore.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF MIDDLEBURG HEIGHTS, STATE OF OHIO, AS FOLLOWS:

Section 1: That the bid of Chieftain Trucking & Excavation for the 2021 City Hall Park Detention Basin Improvement Project in the amount of \$107,964.00 being the lowest and best bid submitted pursuant to legal advertisement and specifications prepared by the City Engineer, be and the same is hereby accepted.

Section 2: That there is hereby appropriated \$107,964.00 from the Capital Improvement Fund to implement this Resolution.

Section 3: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements, including Chapter 107 of the Middleburg Heights Code and Section 121.22 of the Ohio Revised Code.
