**A RESOLUTION
ACCEPTING THE BID OF THE VALLEJO COMPANY
FOR THE 2021 STREET REPAIR PROGRAM
PHASE 4 GLENRIDGE AVENUE**

WHEREAS, pursuant to legal advertisement duly made, sealed bids were received on August 16, 2021, for the 2021 Street Repair Program Phase 4 Glenridge Avenue in accordance with specifications prepared by the City Engineer. The work generally includes asphalt pavement resurfacing and full depth concrete pavement repairs; and

WHEREAS, the bid of The Vallejo Company, 4000 Brookpark Road, Cleveland, OH 44134 for the 2021 Street Repair Program Phase 4 Glenridge Avenue in the amount of \$189,966.25 is determined to be the lowest and best bid, therefore.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF MIDDLEBURG HEIGHTS, STATE OF OHIO, AS FOLLOWS:

Section 1: That the bid of The Vallejo Company for the 2021 Street Repair Program Phase 4 Glenridge Avenue in the amount of \$189,966.25 being the lowest and best bid submitted pursuant to legal advertisement and specifications prepared by the City Engineer, be and the same is hereby accepted.

Section 2: That the Mayor and Finance Director are hereby authorized to enter a contract with The Vallejo Company, 4000 Brookpark Road, Cleveland, OH 44134 in accordance with Section 1 of this Resolution.

Section 3: That there is hereby appropriated \$189,966.25 from the Street Infrastructure Improvement Fund to implement this Resolution.

Section 4: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements, including Chapter 107 of the Middleburg Heights Code and Section 121.22 of the Ohio Revised Code.
