AN ORDINANCE
ENACTING ADMINISTRATIVE CODE SECTION 123.XX ENTITLED
ASSISTANT DIRECTOR OF PUBLIC SERVICE AND ESTABLISHING
THE FULL-TIME POSITION OF ASSISTANT DIRECTOR OF PUBLIC SERVICE

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MIDDLEBURG HEIGHTS, CUYAHOGA COUNTY, STATE OF OHIO:

Section 1. That the Administrative Code Section 123.XX is hereby enacted and shall read as follows:


123.XX FULL-TIME ASSISTANT DIRECTOR OF PUBLIC SERVICE

(a) There is hereby established the full-time position of Assistant Director of Public Service. Such employee shall be appointed by the Director of Public Service and shall serve at his or her pleasure. The duties of the Assistant Director of Public Service shall be to assist the Service Director in the operation of the Service Department as determined by the Service Director.

(b) Salary Grade: 35

Section 2. That it is hereby found and determined that all formal actions of this council concerning and relating to the passage of this ordinance were adopted in an open meeting of this council, and that all deliberations of this council and any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements including chapter 107 of the Codified Ordinances and section 121.22 of Ohio Revised Code.
