**A RESOLUTION  
APPOINTING DAVID BORTOLOTTO TO SERVE AS THE  
REPRESENTATIVE OF THE MIDDLEBURG HEIGHTS CITY COUNCIL  
ON THE BOARD OF TRUSTEES OF THE  
SOUTHWEST COMMUNITY HEALTH SYSTEM**

WHEREAS, under the provisions of the Revised Code of Ohio Sections 749.01 and 5705.191 municipal corporations are authorized to levy and collect a tax upon their taxable property and to pay the proceeds thereof to a general hospital for the maintenance and support thereof and as compensation for its use; and

WHEREAS, the Hospital is a corporation not for profit organized under the Ohio laws for charitable purposed and is operating a general public hospital in the City of Middleburg Heights and has promised to provide treatment to the sick and disabled inhabitants of the City; such treatment to be free to the inhabitants of the City, except those who in the opinion of the Hospital may be able to pay therefore; and


WHEREAS, the Council wishes to appoint David Bortolotto as the City of Middleburg Heights member on the Board of Trustees of the Southwest Community Health System for the term December 7, 2021 through December 5, 2023.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF MIDDLEBURG HEIGHTS, STATE OF OHIO, AS FOLLOWS:

Section 1: That David Bortolotto shall be and is hereby appointed to serve as the City of Middleburg Heights member of the Board of Trustees of Southwest Community Health System for the term December 7, 2021 through December 5, 2023.

Section 2: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements, including Chapter 107 of the Middleburg Heights Code and Section 121.22 of the Ohio Revised Code.
