**A RESOLUTION
AUTHORIZING THE MAYOR AND FINANCE DIRECTOR TO ENTER INTO
A CONTRACT WITH TRI MOR CORP.
FOR THE 2022 STREET REPAIR PROGRAM PHASE 1
PAULA DRIVE RECONSTRUCTION**

WHEREAS, pursuant to legal advertisement duly made, sealed bids were received on May 12, 2022, for the 2022 Street Repair Program Phase 1 Paula Drive Reconstruction in accordance with specifications on file with the City Engineer; and

WHEREAS, the bid of Tri Mor Corp., 8530 North Boyle Parkway, Twinsburg, OH 44087 for the 2022 Street Repair Program Phase 1 Paula Drive Reconstruction in the amount of \$933,975.00 is determined to be the lowest and best bid, therefore.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF MIDDLEBURG HEIGHTS, STATE OF OHIO, AS FOLLOWS:

Section 1: That the bid of Tri Mor Corp for the 2022 Street Repair Program Phase 1 Paula Drive Reconstruction in an amount not to exceed \$ 933,975.00 being the lowest and best bid submitted pursuant to legal advertisement and specifications on file with the City Engineer, be and the same is hereby accepted.

Section 2: That the Mayor and Finance Director are hereby authorized to enter into a contract with Tri Mor Corp., 8530 North Boyle Parkway, Twinsburg, OH 44087 in accordance with Section 1 of this Resolution.

Section 3: That there is hereby appropriated up to \$933,975.00 from the Street/Infrastructure Capital Improvement Fund to implement this Resolution.

Section 4: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements, including Chapter 107 of the Middleburg Heights Code and Section 121.22 of the Ohio Revised Code.
