A RESOLUTION
AUTHORIZING THE SERVICE DIRECTOR TO DISPOSE OF
A 2007 FORD F-350 TRUCK
NO LONGER NEEDED FOR ANY MUNICIPAL PURPOSE

WHEREAS, the City has title to a 2007 Ford F-350 truck, VIN 1FTWF31557EB18918 which is no longer needed for any municipal purpose; and

WHEREAS, the Cuyahoga County Agricultural Society, dba: Cuyahoga County Fairgrounds, has requested the City to donate said equipment to the Fairgrounds for use on the Fairgrounds property only.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF MIDDLEBURG HEIGHTS, STATE OF OHIO, AS FOLLOWS:

Section 1: That the Service Director is hereby authorized to transfer ownership of the 2007 Ford F-350 truck, VIN 1FTWF31557EB18918 to the Cuyahoga County Agricultural Society.

Section 2. That it is hereby found and determined that all formal actions of this council concerning and relating to the passage of this ordinance were adopted in an open meeting of this council, and that all deliberations of this council and any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements including chapter 107 of the Codified Ordinances and section 121.22 of Ohio Revised Code.
