

PLANNING COMMISSION SIGN APPLICATION

- 1. Any person wishing to have signs presented to the Planning Commission for approval must have <u>all</u> necessary requirements submitted to the Building Division at least <u>15</u> days prior to a meeting. The Planning Commission meets the second and fourth Wednesdays of each month.
- 2. **REQUIREMENTS** Twelve (12) sets of fully colored drawings including:
 - O A fully dimensioned drawing showing the design of the proposed signs
 - o Foundation and anchoring drawing of proposed signs
 - o Fully dimensioned site plan showing the sign location in relation to property lines, rights-of-way, buildings, walks, and drives
 - O Dimensioned elevation drawing to scale, showing the size, sign type, height, support or mounting method, and construction materials
 - For illuminated signs, provide the number and types of lamps and lens material and a statement in writing that the illumination of such sign will comply with Zoning Code Section 1153.12
 - o Colored photographs of existing buildings, if applicable
 - o For ground signs, a sign base landscaping plan shall be provided
 - O Written consent of the owner/landlord of the premises upon which the sign is to be erected or placed
 - O Address numbers are required in at least one location

- o Fully completed application and attached permit form; the signed original must be submitted
- o Sign Application fee of \$100 made payable to the City of Middleburg Heights
- o PDF files of all drawings (USB thumb drive or email to kearley@middleburgheights.com
- 3. When <u>all</u> of the above steps are completed, the signs will be checked for Zoning Code compliance and scheduled on the next available Planning Commission agenda. A representative must attend the meeting.
- 4. After receiving approval, the sign permit fee will be determined by the Building Division. The permit fee must be paid before the sign is erected. All contractors must be registered before installation. Contact the Building Division directly for information. After installation, contact the Building Division for an inspection.

Applicant agrees to be responsible for any necessary repairs to the façade.

ZONING CODE SECTION 1153.12: SIGN ILLUMINATION STANDARDS

- (a) <u>General Requirements</u>. Signs may be externally illuminated, internally illuminated, backlit or illuminated through down lighting unless otherwise provided for in the Chapter. All externally illuminated signs shall employ steady, stationary, shielded light sources directed solely at the sign.
- (b) <u>Flashing Signs.</u> Flashing, blinking, running or sequential lights used in any element of a sign shall not be permitted unless expressly provided for in this Chapter. 215
- (c) <u>Non-Glare and Shielded Lighting.</u> Use of glaring, unshielded or undiffused lights or bulbs shall be prohibited. Lights shall be shielded so as not to project onto adjoining properties or roadways.
- (d) <u>Traffic Hazards</u>. Sign illumination that could distract motorists or otherwise create a traffic hazard shall be prohibited.
- (e) Bare Bulb Illumination. Illumination by bare bulbs or flames is prohibited.
- (f) <u>Intensity</u>. Illumination resulting from all signs and sign lighting on any property in a non-residential zoning district shall not exceed one-half (½) foot candles at a height of five feet (5°) when measured at any point on property in a residential zoning district or at any point on any road right-of-way.
- (g) <u>LED Signs.</u> Electronic changeable copy signs utilizing a light-emitting diode display (LED) shall be permitted subject to the following standards set forth below.
 - (1) An LED sign must be located at least two hundred fifty feet (250') away from the nearest residential land use or residential zoning district.
 - (2) Scrolling animations are prohibited.
 - (3) A message must be displayed for a minimum duration of eight (8) seconds before switching to the next message.
 - (4) Any LED sign shall be encased in stone, brick, cultured stone / brick or similar material.
- (h) <u>LCD Signs</u>. Electronic changeable copy signs utilizing a liquid crystal display (LCD) or other technology that allows the sign to display a series of images shall be permitted subject to the following standards set forth below.
 - (1) An LCD sign must be located at least two hundred fifty feet (250') away from the nearest residential land use or residential zoning district.
 - (2) Scrolling animations are prohibited.

- (3) A message must be displayed for a minimum duration of eight (8) seconds before switching to the next message.
- (4) Any LCD sign shall be encased in stone, brick, cultured stone / brick or similar material.
- (i) <u>Electronic Changeable Copy Sign Lighting Intensity.</u> Electronic changeable copy signs must have the capability to adjust intensity in response to ambient lighting conditions.
