## A RESOLUTION ACCEPTING THE CONSORTIUM BID OF CARGILL, INC. SALT, ROAD SAFETY FOR UNTREATED SODIUM CHLORIDE FOR THE 2022-2023 SEASON (11/1/2022 – 10/31/2023)

WHEREAS, through Resolution 2015-29, the City entered into an agreement with various surrounding municipalities for the purpose of forming a Joint Municipal Improvement Consortium; and

WHEREAS, the City may purchase road salt through its membership in the Joint Municipal Improvement Consortium (JMIC) at a lower rate than if purchased on the open market; and

WHEREAS, the Consortium has received a bid from Cargill, Inc.-Salt, Road Safety, 24950 Country Club Blvd., Suite 450, North Olmsted, OH 44070 for the purchase and delivery of **Untreated Sodium Chloride** in the amount of \$52.21 per ton, dump delivery and \$59.21 per ton, piler delivery for the period November 1, 2022, through October 31, 2023, as set forth in Exhibit A attached hereto, is determined to be the lowest and best bid submitted.


NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF MIDDLEBURG HEIGHTS, STATE OF OHIO, AS FOLLOWS:

Section 1: That the bid of Cargill, Inc. Salt, Road Safety through the Joint Municipal Improvement Consortium, for the supplying of **Untreated Sodium Chloride** in the amount of \$52.21 per ton, dump delivery and \$59.21 per ton, piler delivery for the period November 1, 2022, through October 31, 2023, as set forth in Exhibit A attached hereto, is hereby accepted as the lowest and best bid submitted.

Section 2: That the Mayor and Finance Director are hereby authorized to enter into a contract with Cargill, Inc. Salt, Road Safety, 24950 Country Club Blvd., Suite 450, North Olmsted, OH 44070, in accordance with Section 1 of this Resolution.

Section 3: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements, including Chapter 107 of the Middleburg Heights Code and Section 121.22 of the Ohio Revised Code.
