**A RESOLUTION
AUTHORIZING THE MAYOR AND FINANCE DIRECTOR
TO ENTER INTO A CONTRACT WITH MANSFIELD OIL COMPANY OF
GAINESVILLE, INC. FOR THE FURNISHING OF DIESEL FUEL**

WHEREAS, pursuant to Ohio Revised Code Section 9.48, through Resolution 2014-64 the Service Director was authorized to apply for membership in the National Joint Powers Alliance, now known as Sourcewell, to participate in cooperative purchasing for the acquisition of equipment, materials, supplies, or services; and

WHEREAS, the City desires to retain the services of a competent and qualified contractor to provide certain equipment, products, or services to the City; and


WHEREAS, Mansfield Oil Company of Gainesville, Inc. offers government pricing through Sourcewell and is competent and qualified to furnish diesel fuel to the City and has provided a responsive and responsible proposal, and desires to provide diesel fuel.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF MIDDLEBURG HEIGHTS, STATE OF OHIO, AS FOLLOWS:

Section 1: That the Mayor and Finance Director are hereby authorized to enter into a contract with Mansfield Oil Company of Gainesville, Inc. to provide Diesel Fuel to the City, a copy of which is on file in the Council Office.

Section 2: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements, including Chapter 107 of the Middleburg Heights Code and Section 121.22 of the Ohio Revised Code.
