Dear Resident

In an effort to quickly assist you with reducing the risk of sanitary sewer backups, Mayor Matthew J. Castelli and Middleburg Heights City Council created the Sanitary Sewer Backup Reduction Grant (SSBR Grant) on September 12, 2023. The SSBR Grant was developed to provide Middleburg Heights homeowners with direct financial assistance for home improvement projects designed to reduce the risk of sanitary sewer backups. Eligible projects include: the elimination of sanitary sewer cross connections; the replacement of sanitary sewer laterals; the lining of sanitary sewer laterals; the installation of backwater prevention devices; and other similar sewer backup protection measures approved by the City.

The SSBR Grant will provide a reimbursement of 100% of the project cost, up to \$2,500.00. To qualify for this grant, an owner-occupied single family residential dwelling must have experienced a sanitary sewer backup on or after July 20, 2023. An application, W-9 (IRS Request for Taxpayer Identification Number and Certification), and proof of ownership are required, prior to grant approval. Once received the Department of Public Service will authorize the dye testing and televising of your sanitary sewer lateral as the final step of the application process. Please see the application process outline on page 4 of this packet for more details. Once your project has been completed, please return the completed reimbursement requests along with your contractor's itemized invoice, proof of payment, and a copy of the approved final inspection report.

The City of Middleburg Heights is committed to helping identify possible causes of your sewer backup and reducing the chances of any future backups. Please see the attached SSBR Grant Program Conditions on the back of this letter for complete eligibility requirements, qualified projects, and terms.

SANITARY SEWER BACKUP REDUCTION GRANT PROGRAM CONDITIONS

Eligibility Requirements


- Owner occupied single family residential dwelling
- Experienced a sanitary sewer backup on or after Thursday, July 20, 2023
- Sanitary backup is unrelated to a failure of the owner's private septic system
- Sanitary lateral must be snaked, dye tested, and televised by Cuyahoga County Department of Public Works, CCDPW (no charge to homeowner), prior to grant approval
- CCDPW must locate or install test "T" / cleanout (no charge to homeowner), prior to grant approval

Eligible Projects

- Elimination of sanitary sewer cross connections
- Replacement of sanitary sewer laterals
- Lining of sanitary sewer laterals
- Installation of backwater prevention devices
- Other similar sewer backup protection measures approved by the City

Terms

- Applications must be submitted in person, with proof of ownership, and approved prior to the commencement of any work
- Should the funding allocation for this program be reached, a wait list will be created for the next funding cycle
- One time reimbusement, regardless of project or ownership, of 100% of project cost up to a maximum of \$2.500.00
- The SSBR Grant is considered as taxable income
- Reimbursement requests require submission of contractor's itemized invoice, proof of payment, a completed IRS W-9 form, and an approved final inspection report
- Reimbursement requests will only be paid by check to the applicant
- City's commitment to grant reimbusement valid for 150 days, reimbursement requests submitted following that time period will be rejected
- Dwelling must be legally connected to Middleburg Heights sanitary sewer collection system.
- Illegal connections to sanitary system (downspouts, sump pumps, etc.) must be disconnected and rerouted to appropriate outlet
- Applicant agrees to allow CCDPW to dye test, smoke test, and televise sanitary and storm sewer laterals prior to grant approval
- Any deficiencies identified CCDPW must be remedied
- Work must be completed by a contractor registered with the City of Middleburg Heights
- All work must be completed in accordance with all applicable local and state building and utility codes
- Contractor must obtain a permit, inspections, and all required approvals
- Middleburg Heights permit and inspection fees will be waived
- Prior to digging contact the Ohio Utilities Protection Service (8-1-1 or 1-800-362-2764) prior to digging
- Applicant agrees to maintain any backwater prevention devices per manufacturer's specifications
- Applicant is responsible for removal and reinstallation of any backwater prevention devices prior to and after any maintenance conducted by CCDPW
- City of Middleburg Heights is in no way liable for system failures, future claims related to unacceptable workmanship, or any damage resulting from sanitary sewer backup or flooding, or any other claims
- Applicant understands that any work performed pursuant to this program does not guarantee the elimination of all risk of sanitary sewer backups

SANITARY SEWER BACKUP REDUCTION GRANT Helpful Information

Process

- Complete SSBR Grant application
- Return completed SSBR application, W-9, and proof of ownership
- Contact the Middleburg Heights Service Department to authorize your sanitary sewer lateral dye testing and televising
- Schedule your dye test and televising with the Cuyahoga County Department of Public Works
- Notify the Middleburg Heights Department of Public Service when dye testing is complete
- Obtain SSBR Grant Approval (SSBR Grant Applications will not be approved without the above mentioned documentation)
- Contract with a Middleburg Heigths Building Department registered contractor
- Contractor must obtain a permit from the Middleburg Heights Building Department for any and all work (fee waived)
- Contractor completes planned work within 150 day of approval
- Obtain a approved final inspection from the Middleburg Heights Building Department
- Submit a reimbusement request, invoice, proof of payment, and approved final inspection report to the Middleburg Heights Service Department
- Once reimbursement request has been approved, the City of Middleburg Heights will issue a check to the applicant within 7 – 10 days

Purpose of Form

An individual or entity (Form W-9 requester) who is required to file an information return with the IRS must obtain your correct taxpayer identification number (TIN) which may be your social security number (SSN), individual taxpayer identification number (ITIN), adoption taxpayer identification number (ATIN), or employer identification number (EIN), to report on an information return the amount paid to you, or other amount reportable on an information return. Examples of information returns include, but are not limited to, the following.

• Form 1099-INT (interest earned or paid)

- Form 1099-DIV (dividends, including those from stocks or mutual
- Form 1099-MISC (various types of income, prizes, awards, or gross proceeds)
- Form 1099-B (stock or mutual fund sales and certain other transactions by brokers)
- Form 1099-S (proceeds from real estate transactions)
- Form 1099-K (merchant card and third party network transactions)
- Form 1098 (home mortgage interest), 1098-E (student loan interest), 1098-T (tuition)
- Form 1099-C (canceled debt)
- Form 1099-A (acquisition or abandonment of secured property)

Use Form W-9 only if you are a U.S. person (including a resident alien), to provide your correct TIN.

If you do not return Form W-9 to the requester with a TIN, you might be subject to backup withholding. See What is backup withholding,

By signing the filled-out form, you:

Definition of a U.S. person. For federal tax purposes, you are considered a U.S. person if you are:

- . An individual who is a U.S. citizen or U.S. resident alien;
- A partnership, corporation, company, or association created or organized in the United States or under the laws of the United States;
- An estate (other than a foreign estate); or
- A domestic trust (as defined in Regulations section 301.7701-7).

Special rules for partnerships. Partnerships that conduct a trade or business in the United States are generally required to pay a withholding tax under section 1446 on any foreign partners' share of effectively connected taxable income from such business. Further, in certain cases where a Form W-9 has not been received, the rules under section 1446 require a partnership to presume that a partner is a foreign person, and pay the section 1446 withholding tax. Therefore, if you are a U.S. person that is a partner in a partnership conducting a trade or business in the United States, provide Form W-9 to the partnership to establish your U.S. status and avoid section 1446 withholding on your share of partnership income.

In the cases below, the following person must give Form W-9 to the partnership for purposes of establishing its U.S. status and avoiding withholding on its allocable share of net income from the partnership conducting a trade or business in the United States.

- In the case of a disregarded entity with a U.S. owner, the U.S. owner of the disregarded entity and not the entity;
- In the case of a grantor trust with a U.S. grantor or other U.S. owner, generally, the U.S. grantor or other U.S. owner of the grantor trust and not the trust; and
- In the case of a U.S. trust (other than a grantor trust), the U.S. trust (other than a grantor trust) and not the beneficiaries of the trust.

Foreign person. If you are a foreign person or the U.S. branch of a foreign bank that has elected to be treated as a U.S. person, do not use Form W-9. Instead, use the appropriate Form W-8 or Form 8233 (see Pub. 515, Withholding of Tax on Nonresident Aliens and Foreign Entities).

Nonresident alien who becomes a resident alien. Generally, only a nonresident alien individual may use the terms of a tax treaty to reduce or eliminate U.S. tax on certain types of income. However, most tax treaties contain a provision known as a "saving clause." Exceptions specified in the saving clause may permit an exemption from tax to continue for certain types of income even after the payee has otherwise become a U.S. resident alien for tax purposes.

If you are a U.S. resident alien who is relying on an exception contained in the saving clause of a tax treaty to claim an exemption from U.S. tax on certain types of income, you must attach a statement to Form W-9 that specifies the following five items.

- 1. The treaty country. Generally, this must be the same treaty under which you claimed exemption from tax as a nonresident alien.
- 2. The treaty article addressing the income
- The article number (or location) in the tax treaty that contains the saving clause and its exceptions.
- $4. \ \mbox{The type}$ and amount of income that qualifies for the exemption from tax.
- $\,$ 5. Sufficient facts to justify the exemption from tax under the terms of the treaty article.

Example. Article 20 of the U.S.-China income tax treaty allows an exemption from tax for scholarship income received by a Chinese student temporarily present in the United States. Under U.S. law, this student will become a resident alien for tax purposes if his or her stay in the United States exceeds 5 calendar years. However, paragraph 2 of the first Protocol to the U.S.-China treaty (dated April 30, 1984) allows the provisions of Article 20 to continue to apply even after the Chinese student becomes a resident alien of the United States. A Chinese student who qualifies for this exception (under paragraph 2 of the first protocol) and is relying on this exception to claim an exemption from tax on his or her scholarship or fellowship income would attach to Form W-9 a statement that includes the information described above to support that exemption.

If you are a nonresident alien or a foreign entity, give the requester the appropriate completed Form W-8 or Form 8233.

Backup Withholding

What is backup withholding? Persons making certain payments to you must under certain conditions withhold and pay to the IRS 24% of such payments. This is called "backup withholding." Payments that may be subject to backup withholding include interest, tax-exempt interest, dividends, broker and barter exchange transactions, rents, royalties, nonemployee pay, payments made in settlement of payment card and third party network transactions, and certain payments from fishing boat operators. Real estate transactions are not subject to backup withholding.

You will not be subject to backup withholding on payments you receive if you give the requester your correct TIN, make the proper certifications, and report all your taxable interest and dividends on your tax return.

Payments you receive will be subject to backup withholding if:

- 1. You do not furnish your TIN to the requester,
- 2. You do not certify your TIN when required (see the instructions for Part II for details).
- 3. The IRS tells the requester that you furnished an incorrect TIN,
- 4. The IRS tells you that you are subject to backup withholding because you did not report all your interest and dividends on your tax return (for reportable interest and dividends only), or
- 5. You do not certify to the requester that you are not subject to backup withholding under 4 above (for reportable interest and dividend accounts opened after 1983 only).

Certain payees and payments are exempt from backup withholding. See *Exempt payee code*, later, and the separate Instructions for the Requester of Form W-9 for more information.

Also see Special rules for partnerships, earlier.

What is FATCA Reporting?

The Foreign Account Tax Compliance Act (FATCA) requires a participating foreign financial institution to report all United States account holders that are specified United States persons. Certain payees are exempt from FATCA reporting. See Exemption from FATCA reporting code, later, and the Instructions for the Requester of Form W-9 for more information.

Updating Your Information

You must provide updated information to any person to whom you claimed to be an exempt payee if you are no longer an exempt payee and anticipate receiving reportable payments in the future from this person. For example, you may need to provide updated information if you are a C corporation that elects to be an S corporation, or if you no longer are tax exempt. In addition, you must furnish a new Form W-9 if the name or TIN changes for the account; for example, if the grantor of a grantor trust dies.

Penalties

Failure to furnish TIN. If you fail to furnish your correct TIN to a requester, you are subject to a penalty of \$50 for each such failure unless your failure is due to reasonable cause and not to willful neglect.

Civil penalty for false information with respect to withholding. If you make a false statement with no reasonable basis that results in no backup withholding, you are subject to a \$500 penalty.

Criminal penalty for falsifying information. Willfully falsifying certifications or affirmations may subject you to criminal penalties including fines and/or imprisonment.

Misuse of TINs. If the requester discloses or uses TINs in violation of federal law, the requester may be subject to civil and criminal penalties.

Specific Instructions

Line 1

You must enter one of the following on this line; do not leave this line blank. The name should match the name on your tax return.

If this Form W-9 is for a joint account (other than an account maintained by a foreign financial institution (FFI)), list first, and then circle, the name of the person or entity whose number you entered in Part I of Form W-9. If you are providing Form W-9 to an FFI to document a joint account, each holder of the account that is a U.S. person must provide a Form W-9.

a. Individual. Generally, enter the name shown on your tax return. If you have changed your last name without informing the Social Security Administration (SSA) of the name change, enter your first name, the last name as shown on your social security card, and your new last name.

Note: ITIN applicant: Enter your individual name as it was entered on your Form W-7 application, line 1a. This should also be the same as the name you entered on the Form 1040/1040A/1040EZ you filed with your application.

- b. Sole proprietor or single-member LLC. Enter your individual name as shown on your 1040/1040A/1040EZ on line 1. You may enter your business, trade, or "doing business as" (DBA) name on line 2.
- c. Partnership, LLC that is not a single-member LLC, C corporation, or S corporation. Enter the entity's name as shown on the entity's tax return on line 1 and any business, trade, or DBA name on line 2
- d. Other entities. Enter your name as shown on required U.S. federal tax documents on line 1. This name should match the name shown on the charter or other legal document creating the entity. You may enter any business, trade, or DBA name on line 2.
- e. **Disregarded entity.** For U.S. federal tax purposes, an entity that is disregarded as an entity separate from its owner is treated as a "disregarded entity." Line 4, Exemptions

If you are exempt from backup withholding and/or FATCA reporting, enter in the appropriate space on line 4 any code(s) that may apply to you.

Exempt payee code.

- Generally, individuals (including sole proprietors) are not exempt from backup withholding.
- Except as provided below, corporations are exempt from backup withholding for certain payments, including interest and dividends.
- Corporations are not exempt from backup withholding for payments made in settlement of payment card or third party network transactions.
- Corporations are not exempt from backup withholding with respect to attorneys' fees or gross proceeds paid to attorneys, and corporations that provide medical or health care services are not exempt with respect to payments reportable on Form 1099-MISC.
