**A RESOLUTION  
AUTHORIZING THE MAYOR AND FINANCE DIRECTOR TO ENTER INTO  
A CONTRACT WITH CROSSROADS ASPHALT RECYCLING, INC.  
FOR 2024 STREET REPAIR PROGRAM PHASE 1 – GRANT BOULEVARD**

WHEREAS, pursuant to legal advertisement duly made, sealed bids were received on April 16, 2024, for 2024 STREET REPAIR PROGRAM PHASE 1 GRANT BOULEVARD in accordance with specifications on file with the City Engineer; and

WHEREAS, the bid of Crossroads Asphalt Recycling, Inc., 13421 Hawke Road, Columbia Station, OH 44028 for 2024 Street Repair Program Phase 1 - Grant Boulevard in the amount of \$418,582.25 is determined to be the lowest and best bid, therefore.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF MIDDLEBURG HEIGHTS, STATE OF OHIO, AS FOLLOWS:

Section 1: That the bid of Crossroads Asphalt Recycling, Inc. for 2024 Street Repair Program Phase 1 - Grant Boulevard in the amount of \$418,582.25 being the lowest and best bid submitted pursuant to legal advertisement and specifications on file with the City Engineer, be and the same is hereby accepted.

Section 2: That the Mayor and Finance Director are hereby authorized to enter into a contract with Crossroads Asphalt Recycling, Inc., 13421 Hawke Road, Columbia Station, OH 44028 in accordance with Section 1 of this Resolution.

Section 3: That there is hereby appropriated \$418,582.25 from the Street/Infrastructure Capital Improvement Fund to implement this Resolution.

Section 4: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements, including Chapter 107 of the Middleburg Heights Code and Section 121.22 of the Ohio Revised Code.
