**A RESOLUTION
ACCEPTING THE BID OF J.D. STRIPING & SERVICES, INC.
FOR PAVEMENT MARKINGS**

WHEREAS, pursuant to legal advertisement duly made, sealed bids were received on May 7, 2024, for **PAVEMENT MARKINGS** for the City of Middleburg Heights in accordance with specifications on file in the office of the Clerk of Council; and

WHEREAS, the Service Director is recommending acceptance of the bid of J.D. Striping & Services, Inc., 438 Beecher Avenue, Ravenna, OH 44266 for pavement markings for 2024/2025 in the amount of \$104,194.52 and is determined to be the lowest and best bid; therefore.


NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF MIDDLEBURG HEIGHTS, STATE OF OHIO, AS FOLLOWS:

Section 1: That the bid of J.D. Striping & Services, Inc., 438 Beecher Avenue, Ravenna, OH 44266 for paint striping of certain streets and highways, including paint removal, in the amount of \$104,194.52, per application, to be utilized as needed in accordance with specifications on file in the Clerk's office being the lowest and best bid submitted pursuant to legal advertisement and specifications on file in the Clerk's office, be and the same is hereby accepted.

Section 2: That there is hereby appropriated from the Street/Infrastructure Capital Improvement Fund sufficient funds to implement this Resolution.

Section 3: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements, including Chapter 107 of the Middleburg Heights Code and Section 121.22 of the Ohio Revised Code.
