**A RESOLUTION
AUTHORIZING THE MAYOR, OR HIS DESIGNEE, TO FILE AN APPLICATION
FOR THE OHIO DEPARTMENT OF NATURAL RESOURCES NatureWorks
GRANT FOR THE CENTRAL PARK NATURE PLAY AREA**

WHEREAS, as part of the NatureWorks program, the Ohio Department of Natural Resources (ODNR) awards grants to support new outdoor recreation projects in local communities across the state; and

WHEREAS, these grants help to improve and upgrade outdoor spaces for citizens of Ohio with the development of playgrounds, natural playscapes, trails, restrooms, dog parks, baseball fields, basketball courts, tennis and pickleball courts, splash pads, and picnic shelters; and

WHEREAS, the City of Middleburg Heights desires financial assistance under the NatureWorks Grant Program for a Central Park Nature Play Area.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF MIDDLEBURG HEIGHTS, STATE OF OHIO, AS FOLLOWS:

Section 1: That the Mayor, or his designee, is hereby authorized to execute and file an application with the Ohio Department of Natural Resources and to provide all information and documentation required to become eligible for possible funding assistance.

Section 2: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements, including Chapter 107 of the Middleburg Heights Code and Section 121.22 of the Ohio Revised Code.
