**AN ORDINANCE
ACCEPTING THE PLAT AND STREET DEDICATION FOR A CERTAIN PORTION
OF SHELDON ROAD AS SHOWN ON THE DEDICATION PLAT**

WHEREAS, a portion of Sheldon Road as shown in gray on the dedication plat has been offered for dedication; and

WHEREAS, the Council of the City of Middleburg Heights wishes to accept the Dedicated Area-Parcel B as shown on the Dedication Plat.


NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MIDDLEBURG HEIGHTS, STATE OF OHIO, AS FOLLOWS:

Section 1: That a portion of Sheldon Road, permanent parcel number 371-17-016 Parcel B along Sheldon Road, as shown in gray on the Dedication Plat attached hereto and marked "Exhibit A" is hereby accepted for dedication.

Section 2: That the Clerk of Council is hereby authorized to sign the attached Dedication Plat.

Section 3: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements, including Chapter 107 of the Middleburg Heights Code and Section 121.22 of the Ohio Revised Code.
